WHEREAS, basic management principles clearly indicate that for an volunteer organization to effect change and effective management and leadership of that change takes longer then in an organization that is established to create a profit; and

WHEREAS, an annual election of the Department of Arkansas Commander is required by the Department of Arkansas Constitution per Section 1; therefore, be it

RESOLVED, at The American Legion Department of Arkansas Department Convention in North Little Rock, AR, June 16, 2024, change American Legion Department of Arkansas Constitution, Article VI, Section 1 to read as follows,

Section 1. The Department Convention will elect a Department Commander, a Department First Vice Commander; a Department Second Vice Commander; a Department Third Vice Commander; a Department Fourth Vice Commander; and a Department Historian. The Department of Arkansas will be divided into four areas with four Districts per area, these to be known as North-Western Area, with Districts No's. 1, 2, 13 and 16; North-Eastern Area, with Districts No's. 3, 4, 5 and 6; South-Western Area with Districts No's. 11, 12, 14 and 15; Southeastern Area, with Districts No's. 7, 8, 9 and 10. A Senior Vice Commander shall be selected from the North-Western Area for the Legion year of 1967, and each succeeding year the Senior Vice Commander shall be designated by moving clockwise around the State. This would enable each Area to have the Senior Vice-Commandership every four years. The Department Commander may succeed themselves for one additional year, but are required to announce their intention and be elected by the Membership per this Constitution. Department Vice Commanders shall not be eligible to succeed themselves.

WHEREAS, the Charter of the American Legion National Constitution and By-Laws Article XIII – Discipline details the process to be followed in taking cancellation, suspension and revocation actions towards Posts for any good and sufficient cause;

WHEREAS. the current Department Constitution, Article XIII – Discipline, Section 1 states only that The Department Executive Committee, after notice and a hearing, may suspend or with the approval of the National Executive Committee, revoke the charter of a Post which violates this constitution or which fails adequately to discipline any of its members for any such violation, and may provide for the government and administration of such Post during such suspension or upon such revocation clearly not meeting national requirements; and

WHEREAS: the current Department Constitution By-Laws, Article V – Charters, Section 2 states that the Department Commander may order a Post to surrender their charter, a violation of the National Constitution and By-Laws; and

WHEREAS: the current Department Constitution By-Laws, Article V – Charters, Section 3 states that the procedure for revocation, cancellation, or suspension of Post charters shall be in accordance with the uniform code of procedure for the revocation, cancellation, or suspension of Post charter adopted by the national Executive Committee pursuant to provisions of the National By-Laws, however the only documented titled Uniform Code of Procedure document published by the American Legion is for the Organization of National Conventions; and

Said subcommittee shall make its written findings and recommendations to the Department Executive Committee for its approval or rejection, and the action of said Department Executive Committee upon such findings and recommendations shall be final and conclusive.

Section 3. The hearing and trial of any cause involving the cancellation, suspension, or revocation of the charter of any Post in The American Legion Department of Arkansas shall be had and held under rules of procedure to be adopted by the National Executive Committee.

Section 4. Upon suspension of the charter of any Post of The American Legion Department of Arkansas, the Department Executive Committee is authorized, empowered and directed, by and through its duly authorized agents, to take possession, custody and control of all of the records, property and assets of and belonging to such Post, and to provide for the government and administration of such Post during said suspension.

Section 5 The Department cannot provide for the government and/or administration of a Post without first suspending that Post through first performing an investigation to determine facts and conducting a hearing, to determine if a suspension or revocation of a charter is in order.

WHEREAS, the American Legion National Constitution and By-Laws Article IV – Discipline of Post and Post Members clearly states in Section 1 that each Post of The American Legion shall be the judge of its own membership, subject to the restrictions of the Constitution and By-Laws, except that no person who is a member of an organization which has for its aim the overthrow of the United States Government by force or violence, or who subscribes to the principles of any group opposed to our form of government, shall be eligible to become or remain a member of The American Legion; and

WHEREAS, the American Legion National Constitution and By-Laws Article IV – Discipline of Post and Post Members states in Section 2 that a Post may suspend or expel a Post member from The American Legion only after providing the member due process and a proper showing of cause. Charges shall be based upon disloyalty, neglect of duty, dishonesty and/or conduct unbecoming a member of The American Legion. All charges must be made under oath in writing by the accusers, and no member in good standing shall lose their membership until given a fair trial by the Post or Department in such manner and form as the Post or Department By-Laws and 15 Post or Department Executive Committee shall prescribe; and

WHEREAS, the American Legion National Constitution and By-Laws Article III - Department Organization, Section 4 that the Department Executive Committee shall define the powers of such intermediate groups, but in no event shall such powers invade the prerogatives now vested either in the Post or Department or National Organization; and

WHEREAS, the American Legion 2022 Officer's Guide and Manual of Ceremonies states: A member is considered to be in uniform if wearing an official Legion uniform cap; and

WHEREAS, the American Legion 2022 Officer's Guide and Manual of Ceremonies states: The Legion uniform cap should be worn by its members only when in attendance at official Legion meetings or ceremonics or as official guests at patriotic or other civil functions or by individuals when officially representing The American Legion on public occasions; and,

WHEREAS, The Officer's Guide and Manual of Ceremonies states: Female members of the Legion should wear their caps in the manner prescribed for female personnel of the armed services; and,

WHEREAS, American Legion Resolution No. 58: Official American Legion Caps established that the color of the headgear represents the respective level of leadership/duties performed: i.e. Red for National, White for Department, Blue/White for District and County, and Blue for Post levels; and,

WHERE AS, American Legion Resolution No. 58, Section 6b establishes a limitation on the wearing of different color headgear by stating: "No member of any organization, such as drum and bugle corps, bands, and so forth, sponsored by any post or intermediate organizations between the department and post levels, or by any department, shall wear the overseas cap having the color, or combination of colors, authorized for the sole use of county, district, department, or national officers, when the members of uniformed groups are not appearing in the full uniform of their group;" and,

WHEREAS, the American Legion National Constitution and By-Laws Article IV – Discipline of Post and Post Members clearly states in Section 1 that each Post of The American Legion shall be the judge of its own membership, subject to the restrictions of the Constitution and By-Laws, except that no person who is a member of an organization which has for its aim the overthrow of the United States Government by force or violence, or who subscribes to the principles of any group opposed to our form of government, shall be eligible to become or remain a member of The American Legion, and

WHEREAS, the American Legion National Constitution and By-Laws Article IV – Discipline of Post and Post Members states in Section 2 that a Post may suspend or expel a Post member from The American Legion only after providing the member due process and a proper showing of cause. Charges shall be based upon disloyalty, neglect of duty, dishonesty and/or conduct unbecoming a member of The American Legion. All charges must be made under oath in writing by the accusers, and no member in good standing shall lose their membership until given a fair trial by the Post or Department in such manner and form as the Post or Department By-Laws and 15 Post or Department Executive Committee shall prescribe, and

WHEREAS, the American Legion National Constitution and By-Laws Article III – Department Organization, Section 4 that the Department Executive Committee shall define the powers of such intermediate groups, but in no event shall such powers invade the prerogatives now vested either in the Post or Department or National Organization, and

WHEREAS: the American Legion 2022 Officer's Guide and Manual of Ceremonies states in Section 2, Manual of Ceremonies, paragraph 7 "Each officer shall be equipped with the official cap and proper official badge of the respective office." and,

WHEREAS, the American Legion 2022 Officer's Guide and Manual of Ceremonies states: A member is considered to be in uniform if wearing an official Legion uniform cap; and

WHEREAS, the American Legion 2022 Officer's Guide and Manual of Ceremonies states: The Legion uniform cap should be worn by its members only when in attendance at official Legion meetings or ceremonies or as official guests at patriotic or other civil functions or by individuals when officially representing The American Legion on public occasions; and,

WHEREAS, The Officer's Guide and Manual of Ceremonies states: Female members of the Legion should wear their caps in the manner prescribed for female personnel of the armed services; and,

WHEREAS, American Legion Resolution No. 58: Official American Legion Caps established that the color of the headgear represents the respective level of leadership/duties performed: i.e. Red for National, White for Department, Blue/White for District and County, and Blue for Post levels; and,

WHERE AS, American Legion Resolution No. 58, Section 6b establishes a limitation on the wearing of different color headgear by stating: "No member of any organization, such as drum and bugle corps, bands, and so forth, sponsored by any post or intermediate organizations between the department and post levels, or by any department, shall wear the overseas cap having the color, or combination of colors, authorized for the sole use of county, district, department, or national officers, when the members of uniformed groups are not appearing in the full uniform of their group;" and,

WHEREAS: it would be inappropriate and confusing to membership for a Department Finance Officer who is also a Post Commander to wear a white headgear while conducting a Post Membership meeting since the white headgear would indicate that individual is conducting the meeting under the Department level of leadership and authority; now, therefore be it
